HOW TO OBTAIN SACRAMENTAL RECORDS

Requesting a copy of a baptism certificate:

Preferably, you need to write to the parish where you were baptized, stating you need a copy of your baptism certificate **with notations**. In the letter also include your name and mailing address. It is helpful if you can also include the exact date of the baptism or a close estimate of the date. For example, if you know your were baptized soon after birth, then provide your birth date as a reference point for the parish to begin searching for the record.

Requesting a copy of a certificate of confirmation, eucharist or marriage:

Follow the same instructions in #1, except state you are requesting a copy of a certificate for confirmation, first eucharist or marriage. Again, if you can provide an exact or an approximate date of the celebration, that is helpful.
